5. CLIENT RESPONSIBILITIES

The Client agrees to:

- * Provide clear project details and expectations
- * Supply necessary materials (logos, references, etc.)
- * Ensure access to locations and permissions
- * Provide a safe working environment

Delays caused by missing information may affect delivery time.

6. RESCHEDULING

- * Changes requested more than 7 Days before the shoot → free
- * Changes requested less than 7 hours before → €100 fee

7. CANCELLATION

If the Client cancels:

Deposit is non-refundable

Additional costs already incurred must be covered

If the Filmmaker cancels:

Full refund of any payments made

8. USAGE & RIGHTS

The Filmmaker retains ownership of all content created.

The Client receives a non-exclusive license to use the final content for agreed purposes (e.g. social media, website, ads).

Raw footage is not included unless agreed otherwise.

9. LIABILITY

The Filmmaker is not liable for:

* Unforeseen circumstances (weather, technical issues, etc.)

* Missed shots due to restricted access or time limitations

Maximum liability is limited to the total project fee.
